Updates on take-aways from the Committee Members

EOC - Eugene

- No update on COVAX data at this time.
- Rapid Testing: Trained personnel are able to administer the antigen and swabbing instead of someone else doing this. Reached out to Jody Hendry on this to confirm training, etc. and looking at how this might affect things. She did ask if the sector had a preference on which type of antigen testing re: analyzer or non-analyzer box. Eugene feels either would benefit organizations and dependant on their geographic.

DS Sector Vaccine Preparedness 'Ad-Hoc' Committee – Bryan / Lorrie

- On Friday, spoke with Rupert, Christine and Jody from MCCSS. Where we thought that the SOR's would be the tool utilized for tracking, nothing more has been done on this or shared to date.
- Rapid Testing 51 expressions of interest have been submitted with questions around the 'short time lines' and discussed collaborating and testing however unable to organize this within the timeline. Not sure where this piece will go in the future.
- Discussed how we make sure families get the information needed around the vaccine and talked about how to get information out to people. Working with the Board of Education to ensure access to information and for those that are not connected with organizations, etc. There is a variety of ways to do this and Province has been working with advocacy groups.
- Bryan shared that Chris B. was at the meeting and a great deal of discussion was had to ensure
 all are planned for and to think of people with supports coming into their homes and ensuring
 they are protected. This is a broad question that PH is going to be challenged to face and
 hoping further discussion on the way forward can be shared and continue to be an active
 assistance to PH.
- This is the focus of the next webinar and hoping to bring in PH leads or others to this
 conversation to hear how we can assist them to be more successful y planning with DS. Can
 highlight AODA compliance and other great models that have been developed. This can be
 modelled for PH for them to design and plan and support this sector.
- Education now has information to be shared around the vaccine. Talked with the Ministry around expectations for communications.
- Focus is on regional teams and assisting to connect and offer support to PH and Another message is 'get ready', but realize it will now be a waiting game for vaccinations.

Ann-Marie is working with the group for outreach to families. Working on resources and
education videos showing a person receiving the vaccine. The Ministry is providing some funds
to put this together. If anyone has people in the queue to get vaccinated, reach out to AnnMarie to get this videoed.

PN-HR Committee – Eugene

MCCSS Investment

Ann-Marie attended a meeting to discuss the mental health resources for employees and to go
over the proposal. Looking at utilizing the resources for staff with a couple of different
components around: Partnering with CAMH and to access MH first-aid, etc. Looking to take
teams and access micro-brands. Using ECHO program to train the trainer and to build capacity
within organizations. Michelle said the focus was around the Community of Practice and looking
at having sessions at conferences, webinars, etc. Currently providing templates and terms of
reference, and working on putting timelines together.

Labour Challenges – Dave F. – OASIS Labour Relations

- The next meeting is March 19th.
- Hearing earlier today that SEIU has an issue around not taking people swimming, etc. Dave is providing this as a heads-up.
- A Pay Equity ruling came from the Court of Appeal yesterday and this is not looking good. Proxy
 will need to be maintained from when the initial comparison was done. Example: if compared
 with nurses, the target rate should have been kept in sync with this comparator. This could
 have huge ramifications for the sector and economy.

Other

ConnectAbility & Real Xchange Update - Ann-Marie

- Ann-Marie was approached by MCCSS to look at French translation from some resources on RXC. Some key pieces are available to be translated, however not sure of what the parameters are at this time and awaiting on more direction from MCCSS. Ann-Marie may go back to the SPPI group to identify some key pieces they may wish to translate.
- Looking at people not connected with agencies and MCCSS is requesting that ConnectAbility be utilized for connections and resources. There is some dialogue taking place around this.
- Michelle asked if there is a newsletter or something similar that people can register for to ensure regular updates are provided. Ann-Marie will check on this.
- Looking at bumping up the videos and to increase accessibility for people.
- 100 families have registered for the CAMH sessions.
- Translation can look different in different parts of the province, and it is suggested to look at a 'provincial translation service'. Ann-Marie said there is one she used in the past, however sometimes MCCSS utilizes their own.
